5        you're going to regret not playing hockey. I would  
6        like you to call me back. I'd like to help you get  
7        back into hockey. Call me.

2                   What the fuck is wrong with you? You know  
3           what?

5 Message Number Two:

6                   What the fuck is wrong with you? You know  
7           what? You fucking don't understand...

8  
9 Message Number Three:

10                   I'm just calling you to remind you that you  
11           will regret this your whole life by not following  
12           through with what you started. Secondly, I am your  
13           father and I guarantee, Nico, that we will be talking  
14           soon. And when we talk soon, you're going to be  
15           accountable for how you're acting. And I will not let  
16           this fly. I am your father. You will respect me.

17  
18 Message Number Four:

19                   Nico, I just got a call from Joni Canney,  
20           said she ran into you at the mall. Um, I'm going to  
21           tell you something, Nico. You know, you blame me for  
22           a lot of things in your life that have gone wrong.  
23           You think that I'm a bad person. But the one thing  
24           I've never done to you is I've never lied to you. And  
25           then when you figure that out that I've never lied to

1       you, you figured out who had been lying to you, it's  
2       not me that you're going to hate. So good luck to  
3       you, kid, because, um, keep going down the route  
4       you're going, you've got nothing going. And your  
5       mother is going to be the one to blame for this. And  
6       unfortunately for you, you're going to have so much  
7       regret in your life from what she did to you that you  
8       will never look at things the same. Um, you know, I  
9       wish you would pull your head out of your ass and

2 listening to your mother. I'm going to tell you  
3 something, kid, I've done nothing to you, I've never  
4 hurt you, I've done nothing but be a good father to  
5 you. I've given you everything that you've ever  
6 needed. I've given you every opportunity and you're  
7 listening to this crazy crap. You're dropping out of  
8 your sports because why? Why? It doesn't make sense,  
9 Nico. You have all the potential in the world. You  
10 could have made varsity this year, and now Tim  
11 Phoeling's kids are going to make varsity this year  
12 and you're going to sit at home and watch 'em. What's  
13 wrong with you? You're giving up everything you've  
14 worked for. I don't understand it. I'm not staying
